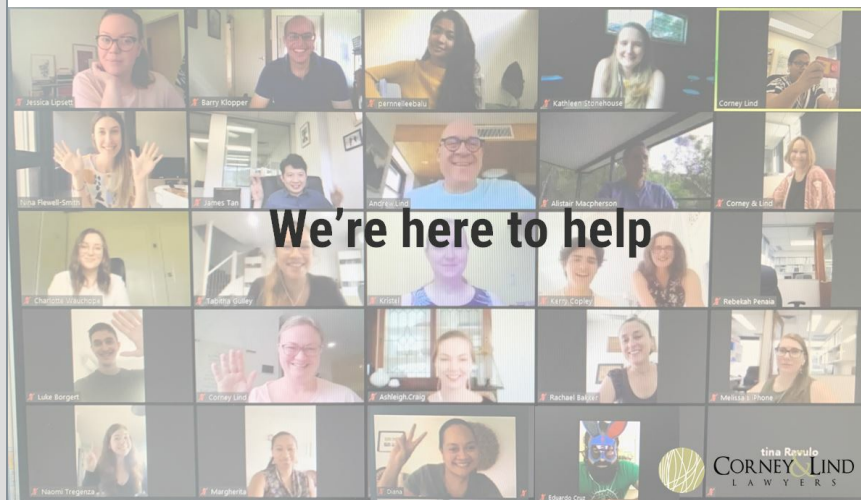

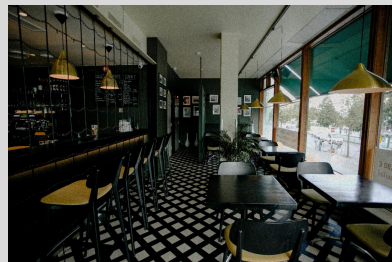


To all our subscribers

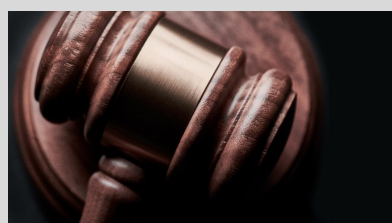
