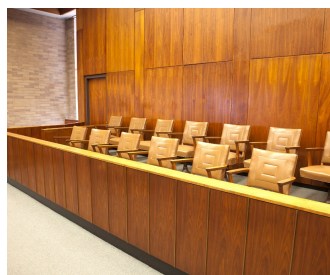


Information Privacy Law as a Current and Evolving Issue
