The first quarter of 2022 has gone so quickly.

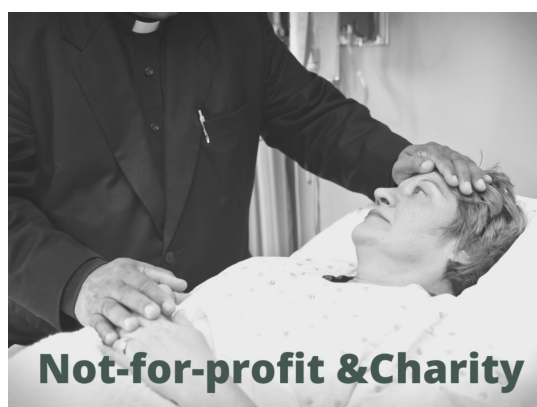

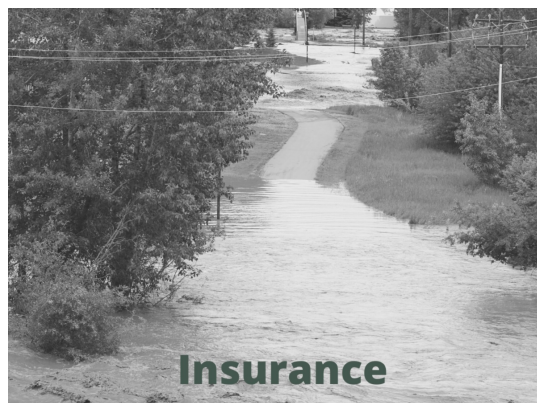
### Not-for-profit & Charity

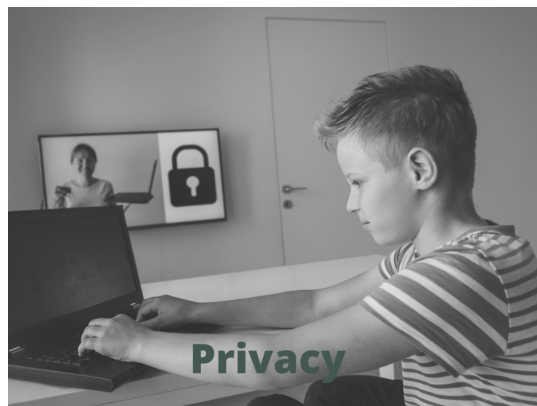


### Compensation
