





Retainer Proposal

We regularly assist schools with a wide range of general legal and governance enquiries, many of which we are already advising on as they arise. For schools seeking greater certainty, responsiveness and value, we also offer flexible retainer arrangements.

A retainer arrangement allows schools to manage this support in a more structured and predictable way. By moving away from ad-hoc billing, schools gain certainty of legal spend across the year, improved budget planning, and the confidence to seek advice early without concern about unexpected costs. This supports better risk management, reduces escalation of issues, and provides ongoing value by embedding legal support into your school's regular operations.

The cost of a monthly retainer is negotiated directly with you, having regard to the size of your school and your anticipated requirements. It covers all general legal and governance advice required by your school on an as needed basis, including for example:

- Advice regarding student protections
- Employee relations
- Parent / School relations
- Policy review and drafting
- Review of services agreements and contracts
- NSSAB or NESA responses
- Fair Work Commission matters up to and including conciliation conference
- Discrimination matters up to and including conciliation conferences.

Retainers exclude significant legal matters that may arise (primarily litigation matters, independent investigations and Fair Work and Discrimination matters that proceed to trial post conciliation conference). These would need to be individually costed (noting that litigation matters of this type would ordinarily be covered by insurance policies and sent by your insurer to their panel lawyers).
